- 1. The sealed bid must be clearly marked with the property reference number and the phrase "Sealed Bid".
- 2. Sealed bids will be opened at the respective Branch Offices and the auction committee shall monitor virtually.
- 3. The Bid shall be accompanied along with Earnest Money Deposit of **Nu. 10,000/-** directly to RICBL or in the form of Cash/Cash Warrant/ Demand Draft in favor of "Royal Insurance Corporation of Bhutan Ltd". The offers without Earnest Money Deposit will be rejected.
- 4. Procedure for quoting price: The offer price shall be quoted for each category of the items as per the bid form provided.
